





Whereas, School Education Department referred 09 posts [OM-07 & RBA-02] of Lecturer vide letter No. Edu/V/4/2008 dated:16.03.2016 in the discipline of Persian for recommendation of selection of suitable candidates; and

whereas, the J&K Public Service Commission advertised these posts vide Notification No. 09-PSC (DR-P) of 2016 Dated 19.03.2016; and

whereas, in response to the above notification, **448** applications were received; and

whereas, the written test of the candidates for selection was conducted on 29.04.2018 in which **290** candidates appeared. The result of the written test was declared vide Notification No. PSC/Exam/2018/56 dated: 27.07.2018 in pursuance of Rule 32(a) of the J&K Public Service Commission (Conduct of Examinations) Rules, 2005 and Rule 40 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and 43 candidates were declared to have qualified the written test and called for interview; and

whereas, the interview of the shortlisted candidates was conducted on 17.08.2018 & 18.08.2018 with the assistance of experts; and

whereas, the Hon'ble High Court in SWP NO.902/2018, MP No.1/2018 titled Shaheena Akhter V/S J&K Public Service Commission through Chairman and another passed orders as below:-

“ Meanwhile, the respondent Commission shall allow the petitioner to appear in the written test for the post of Lecturer 10+2 Persian, scheduled to be held on 29th of April, 2018 in terms of notification dated 20th of March, 2018, at her own risk and responsibility, result whereof shall not be disclosed without leave of this Court.”

whereas, in pursuance of the aforesaid orders of Hon'ble High Court the candidate was allowed to appear before the Interview Board on 18.08.2018, the result whereof has been accordingly withheld.

Now, therefore, on the basis of the performance in the interview coupled with the weight-age accorded to the marks secured in written test in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

Further, the marks obtained by the candidates who appeared in the written examination on 29.04.2018 are given in **Annexure-C** to this notification for information of the candidates.
